Legal update Steve Parisi reported the following:

- A recent article in the Plain Dealer dealt with the Public Records Law. He suggests that every Chief review the Public Records Law and their policies in relation to it.
- Steve commented concerning proposed changes to the CCW law concerning transporting firearms in vehicles and prohibiting law enforcement officers from driving while armed and intoxicated. He suggested review of Sub. House Bill 374.
- A recent Hamilton County case ruling establishes that "A reviewing court cannot reject an arbitrator's findings of fact or interpretation of collective bargaining agreement simply because the court disagrees with them". See Cincinnati v. Queen City Lodge No. 69, F.O.P., 164 Ohio App.3d 408, 2005-Ohio-6225. Court of Appeals of Ohio, First District, Hamilton County.

Speaker for Today's Meeting.

- **Chief Michael McGrath, Cleveland PD** spoke concerning the need for a countywide policy governing vehicle pursuits across city lines. At the conclusion of his presentation he suggested a CCPCA committee research this issue. Chief Guyton appointed Chief McGrath to Chair the Vehicle Pursuit Policy Committee. Chiefs Guyton, Walling, Kocab and Loftus volunteered to serve on the committee.

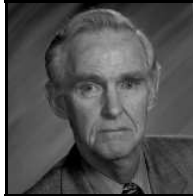
